

Rhode Island SBS Ethics And LTC Initial Course Approval Evidence - 2026-07-07

Summary

SBS/Rhode Island Department of Business Regulation approved the two remaining Rhode Island continuing education course applications on 2026-07-07.

These approvals complete the Rhode Island four-course insurance CE approval set. Rhode Island now has written course approvals for annuity, ethics, LTC initial, and LTC ongoing under Provider 500033149.

No public launch, enrollment/payment, certificate issuance, roster/reporting action, public catalog/indexing, outbound email, portal filing/upload, or code/public-visibility gate was changed in this logging pass.

Boundary

- Approval evidence does not by itself open enrollment, payment, certificates, completion reporting, public catalog visibility, or marketing claims.
- Keep Rhode Island enrollment/payment/certificates/completion reporting closed until the owner intentionally changes launch gates after approval review.
